

# ROYAL THAI EMBASSY, MANILA

## E-VISA REQUIREMENTS AND PROCEDURES

(as of 02 January 2026)

1. **Effective from 1 January 2025, 11:00 hrs. (local time)**, all visa applications with the Royal Thai Embassy, Manila must be submitted online through the official electronic visa (e-Visa) website of the Ministry of Foreign Affairs of Thailand: <https://www.thaievvisa.go.th/>. Applicants are therefore no longer required to physically submit their application in person at the Royal Thai Embassy, Manila.
  - a. Filipino nationals and foreign nationals who are currently in the Republic of the Philippines, and Palau nationals who are currently in the Republic of Palau are eligible to apply for the e-Visa with the Royal Thai Embassy, Manila.

  - c. As most visas have a validity of 90 days, the visa becomes effective from the date of issuance. Please note that applying more than 90 days before the intended arrival date to Thailand may result in the visa expiring before use, requiring the applicant to re-apply for the visa.

**ATTENTION: Please ensure the information provided on the e-visa application is consistent with the information that appears on your travel document.**

- If the travel document has a provision for the middle name, the applicant must input their full name as reflected on their travel document.
- If an applicant has no middle or last name which is also reflected on their travel document, please DO NOT place “N/A” and merely leave the item BLANK.

While the information is automatically captured once the biopage of the travel document is uploaded to the e-visa system, the system prompts the applicant to manually review and correct, if necessary, the auto-generated fields. **Any discrepancies or errors in the personal information of the applicant will lead to visa cancellation without a refund.**

2. **Processing time is approximately 10-15 working days, if complete documents are submitted.**
  - a. If the application is incomplete, the processing time may be extended as the applicant may be requested to provide additional documents and appear for an in-person interview at the Embassy.
  - b. If an e-Visa application is submitted on a Saturday, Sunday, Embassy holiday, the application will be processed on the following working day.
  - c. **The Royal Thai Embassy reserves the right to request additional documents as it deems appropriate** on a case-to-case basis based on Thai Visa and Immigration policies. Therefore, applicants are advised to apply for the e-Visa at least a month before their intended date of arrival to Thailand.
3. Applicants from the following countries ([please click here for the list](#)) are **required to hold a valid Philippine permanent resident visa** before applying for an e-Visa. The above-mentioned applicants who do not hold a valid Philippine permanent resident visa are highly advised to apply with the Royal Thai Embassy in their home country, or with the Royal Thai Embassy which has jurisdiction over their country of residence.

## TOURIST VISA

1. Proof of accommodation (e.g., hotel booking, rental agreement, etc) in Thailand *OR*
  - Letter of Invitation, if invited by a friend or relative living in Thailand
    - a. If invited by a Thai: copy of Thai ID or Thai passport
    - b. If invited by a foreign national: copy of passport, valid Thai visa page, and valid work permit
2. Proof of financials
  - a. For a **single** entry visa request: Recent Bank Certificate, or Bank Statements from the last *three* months with a minimum of USD 2,000 or the equivalent
  - b. For a **multiple** entry visa request: Recent Bank Certificate, or Bank Statements with a minimum of THB 200,000 or its equivalent in other currencies maintained over the last 6 months.

*Note: Bank statements in a language other than English must be submitted together with an English translation.*
  - c. If applicant will have a sponsor to shoulder all travel expenses: Guarantee Letter from sponsor with a copy of sponsor's passport, and sponsor's Recent Bank Certificate or Bank Statements as attached
3. Employment Certificate
  - Student or Enrollment Certificate, *if studying in the Philippines*
  - Marriage Certificate, *if married to a Filipino (with a copy of spouse's valid Philippine government issued ID)*
  - Business Registration, *if the applicant has their own business in the Philippines*
4. Airline Ticket Reservation (Applicants must present **both** dates of entry and exit from Thailand)
5. Valid passport / travel document (valid for at least 6 months)
6. A recent 3.5x4.5cm, or 2x2in photo (white background)
7. Passport
  - a. For minors: Submit a copy of Birth Certificate, and Marriage Certificate of Parents
  - b. Copy of valid ACR I-CARD showing permanent resident visa status in the Philippines (*for nationals from Afghanistan, Algeria, Bangladesh, Cameroon, Central African Republic, China, Democratic Republic of the Congo, Egypt, Equatorial Guinea, Ghana, Guinea, India, Iran, Iraq, Lebanon, Liberia, Libya, Nepal, Nigeria, North Korea, Pakistan, Palestine, Republic of the Congo, Sao Tome and Principe, Sierra Leone, Somalia, Sri Lanka, Sudan, Syria, Yemen*)
  - c. Copy of latest arrival stamp, order issued by the Bureau of Immigration, and Department of Labor and Employment card (for Chinese nationals)
  - d. Copy of Philippine visa (for all other foreign nationals)
8. Medical tourist visa application only: *Documents regarding upcoming medical procedure/treatment/schedule as issued by the hospital or clinic in Thailand*

Visa Fee: PHP 1,800.00 - Single Entry, valid for 90 days

PHP 3,600.00 - Multiple Entry, validity subject to the Embassy's approval

- **ATTENTION:** *No visa fee for Philippine ordinary/regular passport holders – Filipino nationals should indicate the purpose of visit as “Duration of stay no longer than 59 days (Filipino holders of ordinary passports only)” on the e-visa website, since there will be no visa fee collected under the said purpose of visit.*

Period of stay: 60 days (can extend for another 30 days in Thai Immigration)

**NOTE:** The Royal Thai Embassy, Manila reserves the right to reject the visa application with no reason provided. The visa fee is non-refundable.

## **TOURIST VISA (for Nigerian nationals with a valid Philippine permanent resident visa)**

Letter of Invitation, if invited by a friend or relative living in Thailand
  - a. If invited by a Thai: copy of Thai ID or Thai passport
  - b. If invited by a foreign national: copy of passport, valid Thai visa page, and valid work permit
2. *Proof of financials*
  - a. *For a single entry visa request: Recent Bank Certificate, or Bank Statements from the last three months with a minimum of USD 2,000 or the equivalent*
  - b. *For a multiple entry visa request: Recent Bank Certificate, or Bank Statements from the last six months with a minimum of THB 200,000 or the equivalent*
  - c. *If applicant will have a sponsor to shoulder all travel expenses: Guarantee Letter from sponsor with a copy of sponsor's passport, and sponsor's Recent Bank Certificate or Bank Statements as attached*  
*\*must be authenticated by DFA, if proof of financials are from the Philippines*
3. *Employment Certificate, if employed in the Philippines \*must be authenticated by DFA*  
*Student or Enrollment Certificate, if studying in the Philippines \*must be authenticated by DFA*  
*Marriage Certificate, if married to a Filipino (with a copy of spouse's valid Philippine government issued ID) \*must be authenticated by DFA*  
*Business Registration, if the applicant has their own business in the Philippines*  
*\*must be authenticated by DFA*
4. Clearance from the National Drug Law Enforcement Agency (NDLEA) as authenticated by Ministry of Foreign Affairs of Nigeria and the Royal Thai Embassy, Abuja
5. Airline Ticket Reservation (Applicants must present **both** dates of entry and exit from Thailand)
6. Valid passport / travel document (valid for at least 6 months)
7. A recent 3.5x4.5cm, or 2x2in photo (white background)
8. Passport
  - a. Children traveling with parents should submit Birth Certificate and Marriage Certificate of Parents
  - b. *Copy of valid ACR I-CARD showing permanent resident visa status in the Philippines*  
*\*must be authenticated by DFA*
  - c. *NBI Clearance for travel abroad* *\*must be authenticated by DFA*
9. Copy of Yellow Fever Vaccination Certificate

Visa Fee: PHP 1,800.00 - Single Entry, valid for 90 days

PHP 3,600.00 - Multiple Entry, validity subject to the Embassy's approval

*\*Items in red are Philippine documents to be authenticated by the Department of Foreign Affairs (DFA) of the Philippines through a DFA Apostille.*
